Elections & Awards - Jon Dunaway 2024 WSAFM Board Elections

As we do every year, several Director positions for the Association are up for re-election at the Fire Prevention Institute (FPI) in October.

Being a Director for the Association puts you in a unique position to help steer our annual work plan, adjust priorities, and provide input on a host of other initiatives. It also allows you to see how community risk reduction happens across the state and how our efforts intermingle with other organizations. Directors regularly interact with other departments and associations, allowing you to make important connections and expand your network. And of course, it is very rewarding to be involved at this level and see how WSAFM's involvement on many fronts makes a difference for our members and those we serve.

Directors have several roles and responsibilities as they represent the membership of the Association. What is Credentialing – Grant Tinker

What is credentialing?

Professional credentialing is a process that verifies the qualifications and competencies of professionals in the firefighting and EMS field, ensuring they meet established standards of knowledge, skills, and experience. The Commission on Professional Credentialing (CPC) is a recognized organization that provides credentialing services to individuals in a wide range of positions.

The CPC's goal is to promote and enhance the quality of professional services by establishing standards for knowledge, skills, and experience. The CPC designation process includes an application portfolio and oral interview that assess an individual's mastery of their respective field and position.

The CPC currently has designations in the following categories:

- Fire Officer (FO) acting officers are eligible (12 months of acting time minimum)
- Public Information Officer (PIO)
- Chief EMS Officer (CEMSO)
- Chief Training Officer (CTO)
- Fire Marshal (FM)
- Chief Fire Officer (CFO)

Who does the credentialing?

The Commission on Fire Accreditation International (CFAI) and the Commission on Professional Credentialing (CPC) serve different functions in the fire and emergency services community. Both the CFAI and CPC branches fall under the CPSE (Center for Public Safety Excellence). The CPSE is a non-profit organization that provides leadership and support to the fire and emergency services community, with a mission to improve public safety by promoting excellence in fire and emergency services.

The CFAI is an organization that accredits fire departments, providing a comprehensive assessment of the department's operations and services to ensure they meet established standards of performance and quality. Accreditation by the CFAI is a recognition of the department's commitment to excellence and ability to provide the highest service to its community.

On the other hand, the CPC provides professional credentialing/designation services to individuals in the fire and emergency services (think of it as an individual accreditation). The CPC offers certification programs for acting officers, fire officers, fire chiefs, and other related positions, ensuring that individuals meet established standards of knowledge, skills, and experience. By holding a CPC credential, individuals demonstrate mastery of their respective fields and commitment to professional development.

What is the process for becoming a designated officer?

The CPC certification process is rigorous, ensuring that individuals with a CPC credential have the necessary knowledge, skills, and experience to perform their job duties competently and ethically. This helps to ensure that fire and emergency services are performed with the highest level of professionalism and competence, providing the public with the highest level of protection and safety.

The application is thorough and detailed, capturing your past experience, education, professional development, professional contributions, professional memberships, and community involvement. Additionally, there may be up to 20 Technical Competency sections to complete, depending on which designation you are applying for.

Gathering past classes and dates can be challenging if you have not kept good records throughout your career of courses and certifications. Inputting the information required in the electronic application accounts for the bulk of the work of the process. Once all portions of the application portfolio are complete, you submit the application to the CPC Manager. From there, the CPC Manager assigns up to two peer reviewers to read and review your application portfolio. An interview is scheduled, and you will conduct the interview with your peer reviewer(s) over the phone. The interview can take anywhere from 30 to 90 minutes. Once the interview is complete, the peer reviewers will submit the application to the Commission for approval or denial.

The application portfolio is time-consuming, but it is critical to ensure that the application is as comprehensive and polished as possible.

Why is credentialing important? What does it do for me?

The importance of professional credentialing through the CPC lies in its ability to raise the standards of professionalism and promote public protection. The CPC certification process ensures that professionals meet established standards for knowledge, skills, and experience, assuring employers that individuals with the CPC credential are competent and qualified to perform their jobs.

Additionally, having a CPC credential can provide many benefits to individuals. For example, it can provide career advancement opportunities and demonstrate a commitment to professional development. A CPC credential can also give individuals a competitive edge when seeking promotion and employment, as many employers prefer to hire certified professionals.

Moreover, the CPC promotes ethical behavior and best practices in the various professional fields it serves. The CPC sets strict ethical standards for its credentialed professionals, which helps maintain public trust and confidence in their services.

Final note

Arson Alarm Foundation

On average, over 50,000 arson fires are reported annually, causing hundreds of deaths and massive amounts of property damage; Washington state alone has seen \$13,734,000 worth of damages since the year 2000.

Standing against this threat is the Arson Alarm Foundation, a non-profit corporation dedicated to combating the crime of arson in Washington state through inter-disciplinary cooperation and public awareness.

In 1977, amidst a decade marked by an increase in arson cases, a concerned group of private citizens, insurance industry professionals, and members of the fire service conceived a campaign to raise awareness of the life and economic consequences of arson fires. Thus, the Arson Alarm Foundation (AAF) was born.

The AAF was officially introduced to spearhead a multimedia public service advertising campaign, complete with a 24/7 telephone hotline.

Television, radio, and newspaper adverts, outdoor billboards, and bus signage were quickly developed and disseminated throughout the state, showcasing slogans like "Put the heat on arson" and "Arrest arson". At one point, AAF mottos graced the sides of Safeway shopping bags.

In addition to ongoing media efforts, an award program developed in coordination with the Washington Insurance Council, offering monetary incentives to individuals providing information about arson incidents. Since 2000, AAF has awarded \$101,500 to vigilant citizens.

To this day, the AAF remains committed to its mission, empowering citizens to contribute valuable information to the fire service and law enforcement.

Insurance and fire investigators utilize a variety of tools during their investigations; one of the most effective tools are credible tips from reliable sources, supplied directly to the investigating agency. You can nominate someone for an award by visiting the AAF website and filling out the "Nominate a Hero" form.

Through collective effort, we can stave off the potential impacts of arson, preventing incidents and aiding in the successful prosecution of arsonists.

The AAF maintains a \$10,000 annual award fund and operates a toll-free arson hotline (1-800-55-ARSON) for tips regarding arson fires in Washington.

Additionally, the AAF provides several resources to fire departments: collected witness reports, localized advertising, and informational business cards and posters (available in both English and Spanish). Fire departments can request advertising assistance, business cards, and posters by contacting the AAF.

Congressional Fire Service Institute WSAFM Represented by: Dave Kokot

The Congressional Fire Services Institute (CFSI) is held annually in Washington, DC. Two WSAFM Board members participated in the CFSI this year from April 29-30th. Karen Grove (Seattle Fire) was with the Washington Metro Chiefs and Dave Kokot (Spokane Fire) was with the Washington Fire Chiefs. During this time, contingents of fire service representatives from across the country met with their State Legislators and Senators. The meetings are usually limited to 20 minutes and may be with the legislator or with staff.

The primary subjects that were brought by both groups included protecting the FIRE and SAFER grants, improving funding for the US Fire Administration (USFA) and the National Fire Academy (NFA), generating support for Federal Standards for Lithium-Ion batteries and micromobility devices, continuing the National Firefighter cancer registry, wildland urban interface fires, and fire sprinklers. As it happens, the weather was very hot (90 degrees on the 29th and 86 degrees on the 30), which made it a challenge for the participants as we traveled from one building to another.

Of specific note, our meeting with Senator Maria Cantwell was a combined group meeting and lasted over 2 hours. This was mostly due to the meeting being scheduled when she was due to be done with the daily session, but voting took longer. This allowed for a spirited discussion of the issues with staff before she could attend. Once she arrived, the discussion continued and included concerns about opioid abuse.

It is a quick 2 days of meetings and getting from one meeting to the other with scheduling being changed on the fly. Both groups had a coordinator this year so that the presenters did not have to worry about getting to the meeting locations (which can be confusing), just making their presentation.

It was a very positive experience and allowed us to present our concerns to a national level. WSAFM is committed to continue to participate.

Code Corner

State Building Code Council

The 2021 codes have officially taken effect. Of note: there is an Emergency Rule clarifying that Washington does not adopt the model code section regulating BBQ's.

On March 15, the Council filed an emergency rule for the 2021 International Fire Code Section 308.1.4 to make it clear that the restrictions on Open Flame Cooking Devices are not included in the state's building codes. The emergency rule is now in effect. This is the link to the emergency rule filing: https://sbcc.wa.gov/sites/default/files/2024-03/WSR 24 07 059 bbg combined.pdf

The 2024 Group 1 code process has begun; covers IBC, IEBC, IFC, IMC & IFGC. The existing state amendments have already been reviewed; the next step relates to new code proposals.

May 24th Council Meeting Council approves the TAG reports and establishes a submission period for new

statewide amendments.

May 25th – July 24th Submission period for proposed sate amendments

June 21st Council Meeting Council can refer proposals to the appropriate TAGs, deny proposals, or take other

actions.

actions.

ICC Codes – Traci Harvey

The 2027 I-Code cycle has been completed and all proposals submitted. The 1st Committee Action Hearing was held in Orlando April 7th -16th.

This cycle the process has been revised and proposals will have a 2nd chance to be approved by the Committee. cdpAccess will open once the Report of Committee Action Hearing is posted on May 16th. The public comment process will begin again, comments must be relevant to discussion by the committee and may not substantially change the intent of the original proposal.
